

BOARD MINUTES  
Rising Sun-Ohio County Community School Corporation  
December 12, 2019

The regular session of the Board of School Trustees was held as advertised on December 12, 2019 at 5:00 PM in the administration building. Members present were Gary Kinnett, Connie Smith, Andrea Kirkpatrick, Renee Cole, and Superintendent Branden Roeder. Also in attendance was Tim Hillman. Board President Corey Potts arrived later.

The meeting began with the Pledge of Allegiance.

There were no changes to the Agenda.

Minutes for the November 7, 2019 Board Meeting were reviewed. Upon motion by Connie Smith and seconded by Renee Cole to approve the minutes as presented, members voted as follows: Aye – Connie Smith, Renee Cole, Andrea Kirkpatrick, and Gary Kinnett.

Mr. Roeder presented Resolution 2019-4 and an Operating Agreement concerning the Southeastern Career Center. (Included) Madison Consolidated Schools is withdrawing at the end of the school year causing the need to update the bylaws for the Career Center. The resolution and agreement also address the issue of homeschool student and nonmember school costs.
